WHEREAS, the City of Wapakoneta adopted Ordinance 2011-43 which said ordinance was an ordinance enacting §624.16 of the Codified Ordinances of the City of Wapakoneta, regarding the prohibition of the use, possession and/or sale of certain synthetic drugs; and

WHEREAS, the 129th General Assembly of the State of Ohio has adopted Substitute House Bill 64, which became effective October 17, 2011, which amends and/or enacts certain sections of the Ohio Revised Code and the Schedules for Controlled Substances for the State of Ohio regarding certain synthetic cannabinoids and certain synthetic derivatives of cathinone; and

WHEREAS, so as not to have any inconsistencies and/or conflicts with state law, the Council for the City has determined it to be in the best interests of the City to repeal Ordinance 2011-43.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Wapakoneta, County of Auglaize, State of Ohio, to-wit:

SECTION ONE

THAT Ordinance 2011-43 and §624.16 of the Codified Ordinances of the City of Wapakoneta as contained therein, be, and hereby are, repealed.

SECTION TWO

THAT this Ordinance is hereby declared to be an emergency measure, it being for the protection, safety, and welfare of the citizens of Wapakoneta, and for the further reason so as to avoid any inconsistencies and/or conflicts in the enforcement and prosecution of criminal acts involving the use, possession, and/or sale of certain synthetic drugs.
