WHEREAS, declaring the necessity of constructing improvements to include grading, paving, storm water drainage systems, and other related appurtenances (herein the “improvements”) for Short Road between Progress Drive and CR 25A

WHEREAS, no claims for damages alleged to result from or objections to said improvements were filed within the period provided by law for filing such claims or objections;

NOW, THEREFORE, BE IT ORDAINED by the City of Wapakoneta (herein the "City"), County of Auglaize, Ohio, State of Ohio, to-wit:

SECTION ONE

That it is hereby declared to be the intention of this council to proceed with the improvement of the Short Road as part of the Job Ready Site thereof by constructing the Improvements.

SECTION TWO

That the Improvements shall be made in accordance with the provisions of said Ordinance, and in accordance with the plans, specifications, profiles and estimate of cost of the Improvements, approved pursuant to said Ordinance and now on file in the office of the Clerk of Council.

SECTION THREE

That, in compliance with Section 319.61 of the Ohio Revised Code, the Clerk of Council be and is hereby directed to deliver a certified copy of this ordinance to the County Auditor within fifteen (15) days after the date of adoption hereof.

SECTION FOUR

That a contract for the construction of the Improvements shall be let in the manner provided by law, subject to the provisions of Section 727.24 of the Ohio Revised Code, and the cost of the Improvements shall be financed as provided in said Resolution.

SECTION FIVE

That it is found and determined that all formal actions of this council concerning and relating to the adoption of this ordinance were conducted in an open meeting of this council, and that all deliberations of this council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
