WHEREAS, the Streets and Alley Committee of the Wapakoneta City Council has reviewed finances available for street improvements in 2011 appropriations and

WHEREAS, said committee has recommended that Highland Ave from Silver Street to Franklin Ave, Franklin Ave from Highland Ave to Wheeler Lane, and Wheeler Lane from Franklin Ave to Silver St should be considered for asphalt overlay during the construction season of 2011.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Wapakoneta, County of Auglaize, State of Ohio, to-wit.

SECTION ONE

THAT the Director of Public Safety and Service is hereby authorized to set specifications, advertise for bids, and execute an asphalt overlay contract to provide materials, labor, and equipment to provide improvements to Highland Ave from Silver Street to Franklin Ave, Franklin Ave from Highland Ave to Wheeler Lane, and Wheeler Lane from Franklin Ave to Silver St.

SECTION TWO

THAT said funds for this proposed work shall be paid from those appropriated for street improvements in 2011 and the Community Development Block Grant.

SECTION THREE

THAT this ordinance shall be in force from and take effect from and after the earliest period allowed by law.
