## City Refuse & Recycling Costs Explained

With recent discussion of the future of refuse and recycling service in Wapakoneta, please find below an explanation of the costs and fees associated with the service. Please note that this article is targeted toward residential customers.

The flat, monthly fee of \$11.00 for refuse service is used to pay for the operation, maintenance and replacement of the trucks used for pick up, as well as to pay the wages and benefits of the city refuse / recycling workers. The fee for the city garbage bags is used to pay for fees associated with landfill service (often called tipping fees). The majority of this is for disposal and is based upon the weight of the refuse that is being disposed. Some of the fee covers the Auglaize County Solid Waste Management District fees associated with landfill closures, operations, and so forth. A very small portion pays for bag production. The tags available for large and unusual items function in the same fashion as the bags while giving residents options for disposal of unique items.

The projected operating costs for 2018 are as follows:

Refuse Department \$1,186,000
Recycling Department \$110,000
Total Operating Cost \$1,296,000

The projected revenues for 2018 are as follows:

Flat Monthly Fees	\$705,000
Bag Sales	\$350,000
Transfer in to Recycling Fund	\$ 60,000
Yard Waste Sales	\$ 13,000
Fund Carryover	\$136,000
Recycling	\$ 32,000
Total Revenues	\$1,296,000

The current bag system attempts to accomplish two goals. First, charging per individual bag rather than a flat total fee provides an incentive to recycle. Secondly, charging per bag rather than a flat total fee provides a financial charge that is proportional to the amount of refuse a customer produces. Other services are billed in a similar manner. For example, there is a flat fee for having electric service and then there is a usage fee that varies by customer based upon the amount of energy that is consumed.

It is also important to note that there is no additional charge for recycling at this time. In addition to general income tax monies that are budgeted to provide recycling service, money is also transferred out of the refuse fund into the recycling fund to help sustain this service.

As has been noted in recent public meetings, the flat, monthly fee is not covering costs for truck replacement. Several trucks in the fleet are over 20 years in age and are deteriorating rapidly. While the daily operating costs are under control, long term costs need to be addressed.

## Refuse & Recycling Information (continued from the front)

In light of these financial realities, the city has two options at this point:

- 1. Increase the flat, monthly fee by approximately \$5.00 per month (note that this is an informal estimate as no formal analysis or truck bid has been completed) to keep the service as a local utility function. A rate increase would depend upon projected price of replacement of trucks and upon the method selected for paying for them.
- 2. Put the service out for a private bid that will almost certainly use rolling totes for refuse and recycling and, depending upon how the bid is defined, may or may not have recycling incentives and possible sorting requirements.
