Garage Sale Information

Garage sales, including porch, patio, basement, yard, or block sales are subject to the following requirements:

Hours of Operation. Garage sales may be held from 7:00 a.m. to 8:00 p.m. Outside set up and tear down may extend sixty (60) minutes before and after sale hour limits.

Length of Sales. No garage sale may extend for more than three (3) consecutive days (or portion thereof). **Number of Sales.** No more than two (2) garage sales per dwelling unit may be held on any such zoning lot in any calendar year.

On-Premise Sign. One (1) non-illuminated sign not exceeding four (4) square feet in size, or more than three (3) feet in height above grade may be displayed on the property where the sale is being held. Such a sign may be erected no more than forty-eight (48) hours before the sale begins and must be removed within twenty-four (24) hours of the conclusion of the sale.

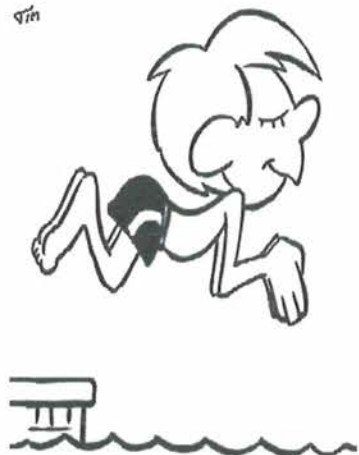
Attention-Getting Devices, special lighting, noise making devices or other similar advertising displays or notices shall not be used to call attention to the garage sale. No permit is required for garage sales. A violation of the requirements of this (section) constitutes a minor misdemeanor punishable as provided in Section 698 of the Codified Ordinances of the City of Wapakoneta, Ohio and each day such violation is continued shall constitute a separate offense.

City Farm Information

The City Farm has opened for the season. Hours are 9:00 a.m. to 5:00 p.m. Monday through Friday, Saturdays from 8:00 a.m. to 2:00 p.m. April through November.

The rates for disposal of brush, tree limbs, grindings, grass clippings, leaves, yard/garden waste and other acceptable materials are as follows:

- Automobiles or van load (Blazer, Bronco, Suburban, etc.) \$3.00
- Pick-up truck or "small" 2-wheel trailer \$6.00
- Dump truck or large trailer \$15.00

Minimum fee of \$3.00 allows the equivalent of two 30 gallon garbage bags, regardless of the type of vehicle used to haul it.

The rates for composted material which can be purchased at the City Farm:

- One scoop from a 2 yard bucket \$27.00
- Garbage Can \$3.00
- Four 5-gallon buckets (minimum charge) \$3.00

The City Farm is a compost facility for the disposal and composting of yard waste only. No paper, plastic or trash is to be deposited with yard waste materials. We cannot accept stumps or building materials.
