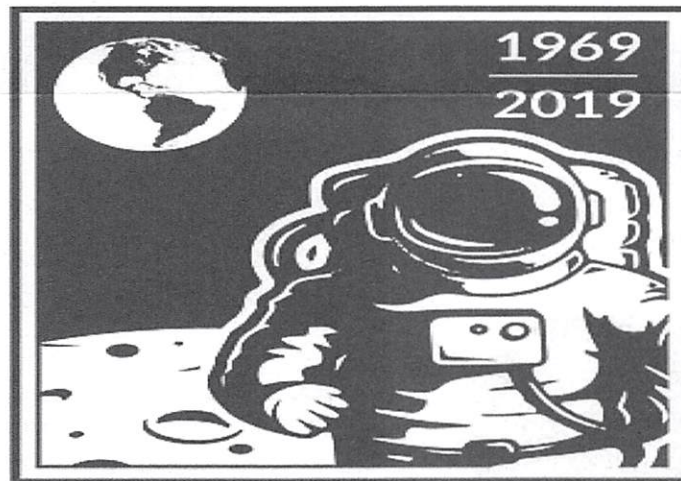

To the Citizens of Wapakoneta,

Thank you for removing your glass from your curbside recycling. We have noticed a big difference in the amount of glass we are getting. As of August 5th, any glass will be left in your bin as a reminder that it is no longer accepted. We don't have a definite date yet for when our Dual Stream truck will be in service, but we anticipate it will arrive in late August. At that time the whole recycling bin will be left if glass is included.

Also, please remember to put your paper and cardboard in separate containers. A small plastic waste can works well, but you can put it in a paper bag or other small container. Please put a couple small holes in the bottom of any containers to allow water to flow out.
