LEAF REMOVAL REMINDER:

The City of Wapakoneta began leaf pick up on October 21st, and we would like to request residents please place leaves between the sidewalk and the street (curb lawn). This will minimize the number of leaves ending up in the catch basins and make it easier on the street department during collection. Thank you.

RECYCLING REMINDER:

Due to changes in the industry the free service of curbside recycling offered to Wapakoneta refuse customers has transitioned to a dual stream system. This will require everyone who wishes to participate in the program to have two recycling bins. We are not requiring that an additional bin be purchased from the city if you already have one red bin, however, if you choose to purchase a bin for your paper and cardboard from somewhere else, we only ask that it be similar in size to your required red bins and that it has drainage holes in the bottom. We are also no longer accepting glass curbside; any glass can be taken to our drop off center at 110 E. Harrison.

Notice to All Voters:

Voters must bring identification to the polls in order to verify identity. Identification may include current and valid photo identification, a military identification, or a copy of a current (within the last 12 months) utility bill, bank statement, government check, paycheck, or other government document, other than a notice of an election or a voter registration notification sent by a board of elections, that shows the voter's name and current address. Voters who do not provide one of these documents will still be able to vote by providing the last four digits of the voter's Social Security number and by casting a provisional ballot pursuant to R.C. 3505.181.

The City Farm will close November 30, 2019

The new fees are as follows:

Type of Vehicle	Flat Disposal Charge
Small automobile (Material less than 5-gallon bucket)	\$1.50*
Automobile, van, "Blazer", "Bronco", "Suburban"	\$3.00*
Pick-up truck or "small" two-wheeled trailer	\$6.00*
Dump truck or "large" trailer	\$15.00*

*A minimum fee of one dollar (\$1.50) will be charged for disposal of material at this facility and shall cover an equivalent volume of material equal to approximately two thirty-gallon garbage bags regardless of the type of vehicle used to haul material to the facility. No other limit is established for the various types of vehicle used.

Hours are 9:00 a.m. to 5:00 p.m. Monday -Friday, and Saturdays 8:00 a.m. to 2:00 p.m. Punch cards for the farm may be purchased at the Utility Office at City Hall. No cash is accepted on site, only the city punch cards.
