Rules and Regulations

1. Violation of the general rules and regulations or any dangerous or unsafe conduct may be cause for permanent expulsion from the Wapakoneta Waterpark at the discretion of the manager, without refund of fees.
2. The Wapakoneta Waterpark may close at the discretion of the manager for any of the following reasons inclement weather, temperatures below 65 degrees, or attendance of 25 people or fewer in the Waterpark an hour before the closing time.
3. Children under 8 years of age must be accompanied and supervised at all times by an individual 18 years of age or older. If the child can pass a swimming test, he/she will be allowed in the water without a parent or guardian, although the adult must remain in close proximity to the child.
4. Children between the ages of 8 and 15 are allowed in shoulder height of water alone, but are required to pass a basic swimming test to use the Slide and Diving Boards.
5. The following are not permitted within the facility: glass containers of any kind, horse play, running, spitting, tobacco products of any kind, alcohol and drug use, splashing or otherwise distracting the lifeguards, hanging on the ropes, inappropriate language, tennis balls, racquet balls, or gum.
6. Diving is permitted in designated areas only.
7. Coolers are permitted and will be inspected upon entrance,
8. Replacement for lost or stolen season pass will cost \$10.00.
9. Diaper-wearing children must use swim diapers in the pool.
10. Appropriate swimming attire is required in the pool. No cut-offs or thong bathing suits are permitted. T-shirts may be worn for sun protection, but only as accompaniment to appropriate swimming attire.
11. Facility staff must be obeyed at all times.
12. Patrons are not permitted to distract lifeguards from their duties.
13. Any person proven to have maliciously damaged the Wapakoneta Waterpark or the adjacent grounds will be held financially responsible for said damage. He or she will lose all swimming privileges for whatever period of time the management considers necessary and proper.
14. Any person caught stealing personal or City property will be permanently expelled from the Wapakoneta Waterpark at the discretion of the manager. The City of Wapakoneta may also pursue prosecution to the fullest extent of the law.
15. Any person who appears to be under the influence of alcohol or drugs will be refused admittance to the Wapakoneta Waterpark at the discretion of the manager.
16. Any person having an infectious or open sore may be refused admission at the discretion of the manager.
17. Personal music devices must be kept at a reasonable volume.
18. Allowable flotation devices-for shallow water only must be Coast Guard Approved.
19. Public displays of affection are prohibited.
20. Roller blades, skates, skateboards, or bikes are not permitted beyond the admission booth.
21. Rest breaks are scheduled the last ten (10) minutes of each hour, signaled by multiple double whistle blows then followed by 1 loud whistle blow. Those 17 and under must exit the pools, except children five (5) and under, who may remain in the water with an adult.
22. Daily admission fees are for the entire day. Admission fees are not required to re-enter the Waterpark during the same day.
23. Long distance underwater swimming and underwater breath-hold diving are prohibited.
24. The Wapakoneta Waterpark is not responsible for lost or stolen items.

Diving Well Rules

1. One person is permitted on the board at a time. The next diver must wait on deck until the board is clear.
2. Before diving, make sure adjacent water is clear of swimmers or divers and that the previous diver has reached the ladder.
3. Dive straight off the end of the board.
4. After diving, swim directly to the nearest ladder and exit the pool immediately.

5. No one is permitted to catch a child diving off the board.
6. Divers are required to pass a basic swimming test before being permitted to dive.
7. Flotation devices are not permitted on the boards or in the diving well area.
8. Use of starting blocks are only permitted under the supervision of a Coach or Instructor.
9. Only one bounce is permitted on the boards.
10. The following are not permitted on the boards: Double Springing, Springing from a seated position, Hanging from the board, Cartwheels, Handstands, Inward Dives, Back Flips, and Back Dives.

Waterslide Rules

1. No Head-first sliding.
2. Parental or Adult supervision recommended.
3. Do not use this slide while under the influence of alcohol or drugs.
4. Follow the instructions of the flume attendant.
5. No running, standing, kneeling, rotating, tumbling, or stopping in the flume.
6. Only one person at a time. Forming "Chains" is prohibited.
7. Keep both hands & feet inside the flume at all times.
8. No diving from the flume.
9. Leave the flume pool promptly after entering.
10. Slide lying on back, feet first only.
11. Patrons must be at least 48 inches tall to use the slide and if 15 years old or younger, must pass a basic swim test.
12. No life jackets, floatation devices, hats, or goggles will be permitted to go down the slide.
