

Parade and Events Regulations

Permit Application

Regulations:

- 1. Parade participants must move at a continuous pace. No gaps should appear in the parade.
- 2. Nothing shall be thrown to the crowd by any participant.
- 3. The designated parade route cannot be deviated from without the approval of the Chief of Police or their designee.
- 4. No paint shall be used to mark the parade or race route. The use of cones or barricades, as directed and installed by the City, shall be used to direct runners at directional changes.
- 5. The permit holder must notify all participants of these regulations and requirements.
- 6. Violations of these regulations will result in the participants' removal from the parade or event with the potential for future permit denial.
- 7. The City will require the payment of personnel costs for the maintenance of public safety by personnel of the City of Wapakoneta Police Department. Any personnel related costs shall be determined by the Department of Public Safety and Service during the permit application review process.
- 8. A \$1 million certificate of liability insurance, naming the City of Wapakoneta as the certificate holder, is required.
